Introduction

The Square Mile's multitude of iconic bridges, tall commercial structures, and public thoroughfares necessitate vigilant preventive measures and strategies to safeguard both residents and the numerous daily visitors from potential high-risk situations.

In 2017, the City of London Corporation initiated a multi-agency Suicide Prevention Steering Group, which eventually led to a comprehensive Suicide Prevention Action Plan articulated around six priorities. This framework encompasses objectives ranging from minimising risks in vulnerable groups to promoting sensitive media reporting on suicide. The work continues to this day.

Due to its close working relationship with key partners, the City of London Corporation can gather data on both suicide attempts and completions. However, as the data refers to events occurring within its geographic area, ost incidents involve individuals who reside elsewhere in London and the country.

The City of London possesses certain unique demographic characteristics that may influence its suicide trends. A notable majority of its rough sleepers, primarily male, experience mental health challenges.

Concurrently, the workforce, predominantly male and aged between 20-50, aligns with the national trend where adult males are most susceptible to suicide.

The City's male-dominant workforce and the younger age profile fit this at-risk group prompting a more tailored approach to suicide Between 2017 - 2022 th 40 deaths by suicide in Mile, with a neak in the suicides in 2017 - seen f and females.

From May 2023, the Mental Health Street Triage has dealt with over 250 people in mental health crisis; police officers would have detained 138 of these under Section 136 of the Mental Health Act, thanks to the expertise and experience of the MHST only 95 of these people ended up being held for assessment at hospital.

The MHST service extends its vision to long-term wellness. and suicide prevention by proactively identifying and working with high-frequency users to create personalised care plans. Preliminary data points to a promising reduction in suicide. rates and an internal evaluation suggested the service may have a positive effect in preventing suicide.

The US definition of Economic Security, as highlighted in the White House fact sheet (published in 2021) emphasises resilient supply chains and international cooperation to address short-term disruptions and long-term challenges. Key actions include streamlining stockpiling efforts, increasing funding for trade facilitation to reduce bottlenecks, and planning a multi-stakeholder summit to build greater global supply chain resilience. These steps aim to ensure stable access to critical goods and materials, promoting national security and economic stability.

China's focus on economic security was officially highlighted and formalised in the National Security Law of 2015 and further expanded through subsequent legislation, such as the Cyber Security Law (2016), the National Intelligence Law (2017), and the Data Security Law (2021). 


